

#### **Chairman's Notes**

What can we say about 2020? It has been an extraordinary and exceptional year and has completely dislocated normal life as we used to know it. We send our sympathy and best wishes to the entire community. There has been much pain and suffering, to health, wealth and to happiness and our sincerest kind wishes go out to all. Thousands of others have written about it already and in excruciating detail - monitoring, measuring and critiquing the steps taken in every country and corner of the world. I can add nothing to this accumulated wisdom except to comment about some of our own direct experiences here in Merrow and to consider a few of the local impacts.

A main highlight was the success achieved by the *Coronavirus Support Volunteers* group that MRA set up at the start of lockdown. We provided services necessary at a local level, not available from GBC, SCC or the government support initiatives.

The major achievement was to ensure that groceries and other daily supplies were delivered to the elderly, infirm and those in need (these were described as the 'ordinarily vulnerable' - those who needed help in lockdown but were not covered in the government list of the 'extremely vulnerable').

We remain most grateful to the volunteers who took on the responsibilities of helping with these very real needs and we are also fortunate within Merrow that the number of residents seeking support was typically about half the number of available volunteers. Clearly disappointing for some of the volunteers, but very much better to have the imbalance in numbers in that direction. Their work is currently suspended, but they wait on standby in case of further spikes during the winter

We also gratefully acknowledge the benefits from working together with *St John's Church* to help identify those needing help and from sharing experiences with *Burpham Community Association* who set up and ran a parallel initiative.

Our delayed virtual 50th AGM in July proved that we could successfully operate socially distanced meetings, via *Zoom* video conferencing. This works well in the current circumstances, and allows potentially for a very wide attendance (though we do understand that it also can make attendance difficult for some of our membership, which we acknowledge and will be seeking ways to mitigate).

We are now planning our *Autumn Even*t online on 19th October and hope that you can join us. The recent restrictions have helped many of us appreciate the natural environment on our doorstep even more. Local residents **Ken** and **Gillian Elsom** have agreed to talk about the butterflies and flora found on *Merrow Downs* and the steps being taken to conserve them.

By holding the event via *Zoom* we can't on this occasion provide our usual spread of nibbles and drinks but instead you can sit comfortably on your own sofa and join us virtually. We will not be limited by hall size, so this is an opportunity to 'invite' friends and neighbours to introduce them to MRA - the more the merrier! (See the back page for more details)

The MRA's ambitions for 2020 have remained constant. We aim to increase the relevance of the Association to everyone in Merrow, to involve more members more actively in more of our activities and to build out our areas of expertise and interest. Many aspects within this plan have been delayed by lockdown and social distancing, but the plan continues.

Stephen Rudd has taken over the mantle of Environment Officer and is developing our relationship with (and our corporate membership of) the Guildford Environment Forum providing access to their broad coverage of so many key environmental subjects.

Other MRA activities include reviewing the new planning regulations, the continuing support given to members on local planning issues and the monitoring and commenting on the roll out of the Local Plan, which becomes ever more convoluted.

Membership costs are kept very low and affordable and we believe that the approach that we are following can encourage growth and wider participation across the community.

Our range of activities are reported both in this newsletter and on our newly revamped website.

#### **PLANNING**

#### Urnfield, Downside Road (20/P/00825)

A full planning application was submitted for the creation of a floodlit artificial hockey pitch with a six-lane all weather running track, a football pitch, relocation of cricket nets, extension to the sports pavilion balcony and new javelin, discus, shot put and long jump areas, alongside the creation of a new store building and additional on-site car parking.

The land is already a sports ground and facility for various local schools, owned/tenanted by *Athena Schools Trust* and the *Royal Grammar School*.

This application on the south-western crest of Merrow Downs has resulted in over 500 responses from local residents and school communities. Supporters and objectors have put forward strong views, as well as interested agencies and parties.

MRA submitted an objection for the following reasons:

#### 1 Floodlights

The current proposal does not conserve or enhance the Area of Outstanding Natural Beauty. The installation of eight 15m high floodlights in this open and prominent position would be highly visible both by day and by night. The floodlights would be lit on autumn and winter afternoons/evenings and light pollution would affect a wide area surrounding Urnfield, impacting on the amenities of many residents downhill to the west and in adjacent roads. We proposed that GBC commission a further independent

study, with onsite testing and assessment of the real visual impact of 15m high structures, and to report on light and structural impacts. Mitigations to these visual impacts should be implemented. We further proposed that clear conditions on floodlight usage times are set out.

#### 2 Traffic flow and parking

The proposed site developments would increase traffic in Downside Road and neighbouring residential roads. There are no parking restrictions and often cars and visiting service vehicles are parked on both sides. This results in the difficult manoeuvring of coaches and minibuses, which impacts upon the residents' amenities and safety.

The *Environmental Health Department* of GBC and *Sports England* have recently submitted their further comments to GBC, covering lighting, noise pollution and the layout of the proposed sports facilities.

At the time of writing (September 2020) the Planning Officers are considering their recommendation for approval or refusal, which in any event will be put forward to the full Planning Committee for a final decision in due course.

#### PLANNING RULES from 1st September 2020

The Town and Country Planning (General Permitted Development) Orders 2020

Two amendments to the 2015 Orders have become law:

1. Homeowners will be able to add up to two additional storeys to their home to create new homes or more

living space for growing families through the 'permitted development' approval process and without the need for a full planning application, but with a requirement to carefully consider the impact on neighbours and the appearance of the build

 Full planning applications will not be required to demolish and rebuild unused buildings as homes, and commercial and retail properties can be quickly repurposed to help revive our high streets and town centres.

However, in both situations GBC would have to ensure that the developments meet detailed structural and building requirements.

MRA wrote to the Managing Director of GBC, **James Whiteman**, to seek further guidance and advice for our residents, as the new rules will affect the public in different ways. We are concerned that neighbours and interested parties may not be made aware of the new rules on a development, where previously a full planning application would have been required and notified.

At the time of writing guidance requires GBC to notify only the adjoining property owners. This notification will not be provided to other neighbours or to Residents' Associations. It remains unclear what impact these new rules will have in Merrow and we continue in communication with GBC on this subject.

We always suggest that homeowners remain vigilant about any planning applications or developments around them.

# The Local Plan Little obvious progress has been made with the developments described in the *Guildford Local Plan* although there is a great deal of activity behind the scenes. would be increased when our Local Plan will be re-classified and developers will outline planning consent for land that development in a revised Local Plan. The planning application for *Garlick's Arch* on the A247 at Send Marsh/Burnt Common (for 550 homes) has yet to go to the Planning Committee for determination and there have been four separate virtual presentations on the development of the Slyfield site now called the *Weyside Urban Village* (WUV) (for 1,500 homes). This is a massively complex development involving the construction of a new sewage treatment works, the 'sealing' of old sewage lagoons and landfill sites and the construction of the northern end of the *Sustainable Movement Corridor* (to give priority to buses, cyclists and pedestrians) that snakes through Guildford and links the WUV with the University, the Royal Surrey County Hospital and Burpham and may even stretch to Merrow.

Residents' Associations throughout Guildford have been stunned by the new Government proposals to not only review but make fundamental changes to the procedures by which Local Plans are made. This may well have a fundamental impact on Guildford's Local Plan that was adopted in April 2019 which would have to be re-made within 42 months of the new procedures coming into force.

The Government are suggesting that their proposals will simplify the current system and make it easier for developers to develop on land that has been identified for development. The proposals would change the basis on which housing 'need' is calculated to make it more likely that the Government can meet its target of 300,000 new homes per year. This would mean that it is likely that the current housing target for Guildford of 10,678, to be built over 15 years,

would be increased when our Local Plan is re-made. Land will be re-classified and developers will not have to seek outline planning consent for land that is earmarked for development in a revised Local Plan. The proposals would also do away with many of the detailed policies in the Local Plan and therefore some of the control we now have on the quality and appearance of our new houses and blocks of flats would disappear.

There is no suggestion that the *Green Belt* would be affected but we have to look at the detail when it becomes available to ensure that this guarantee is watertight. There are very few positives in the Government proposals which are full of hyperbole and gloss and unsubstantiated assumptions.

This Government review is not only disappointing after all the work that the MRA put into the 2019 Local Plan but deeply worrying since Guildford would have some difficulty in finding additional land for development if our housing target were to be increased without further erosion of the *Green Belt* that is one of the key features of this lovely area in which we are so fortunate to live.

Members may have heard that the Government is also proposing that more unitary authorities should be established that would do away with borough and district councils in favour of one authority which would carry out all the functions which are currently the responsibility of Surrey County Council (SCC) together with all the eleven other local authorities in the county including those of Guildford Borough Council (GBC). This proposal is being supported by SCC but opposed by all major political parties in Guildford and also by GBC itself. It is argued that the establishment of a unitary authority would be more efficient and cost effective but it would certainly increase the degree of separation between residents and decision makers and is likely to be extremely unpopular and divisive.

As we are finalising this edition of *Merrow Life* there is a war of words raging on the possibility that Guildford Borough Council may disappear within a single new unitary authority. On the one hand you have the leader of SCC who has written to the Department of Housing, Communities & Local Government supporting this initiative whilst on the other all the Borough and District Councils in the County are mounting a robust rebuttal of the suggestion. Then things got more interesting when it was suggested in a leaked email that the Government had gone off the idea but this was swiftly followed by a statement from the leader of SCC that the idea was still live. We shan't know the truth of the matter until the Government's White Paper on *Recovery and Devolution* is published in the autumn. Until then we are all really in the dark.

#### Merrow's New Defibrillator

Beating Hearts Merrow would like to thank the very generous local residents and organisations who have made it possible to purchase a public access defibrillator for Merrow. It will be installed ready for launch on 10th October close to the Epsom Road shops on a wall near to Close Shave barber's shop. With very visible signs it will be difficult to miss!

The timing is significant, as it will be a year since **Judith Hunt** had a sudden cardiac arrest and her heart stopped beating. She was resuscitated through use of a defibrillator, which shocks the heart into restarting. After making a full recovery Judith set up *Beating Hearts Merrow* to fundraise for a local defibrillator, and offer *Save a Life* training sessions.

Judith has been completely overwhelmed by the support she's had. "Our target was to raise funds for one defibrillator and now we only need to raise £400 and we can order a second one!"

She is also committed to giving people the confidence to actually use a defibrillator and is holding a mix of in-person and virtual *Save a Life* sessions.

On 10th October when the defibrillator is 'unveiled', advice on using it will be available. Following on from this, virtual Save a Life sessions will be held on Zoom on Saturday 17th October. For more information see beatingheartsmerrow.uk/ or email savealife@beating-heartsmerrow.uk

## **MERROW HISTORY GROUP**


The group met three times during the year until the pandemic caused all later meetings to be cancelled. Topics we covered included a talk on smuggling (which had dubious Merrow connections) and on House of Commons Speakers (with definite Merrow connections!) Limited new research has been possible since then although the Woking History Centre and the Guildford Institute, both useful sources of information, have partially reopened.

During the lockdown we dealt with many of our longstanding repair jobs and then finally our sheds, attics and cupboards were sorted. If you did the same, what treasures did you find? They may be items of local interest that you no longer need to keep but you don't wish to bin. Alternatively, have you unearthed any items we might be interested in but you want to retain?

We have recently seen the sale particulars of *The Gate House*, dated 1936. Located where Gateways is now (off Epsom Road), it was within Merrow at that time. The property was described as "a picturesque country estate of around 9 acres. The main house being in the Jacobean style with 10 bedrooms, 2 bathrooms central heating and an Aga." The whole estate was offered for the sum of £8,500 which included a lodge with six rooms (which still exists), garaging for three cars and stabling for three horses.

A few years ago, a clear out to make space for a local house extension unearthed a unique find. The doors from the delivery van used by *H. Kimber and Sons* (the grocers and bakers whose shop was next door to the old village forge and the current BP garage) were about to go to the tip, but we rescued them. Let us know what you can offer - but not too many scrap doors please!

### A First-hand Memory of Kimber's Van

"Bread, and cakes if we were lucky, was delivered daily in a little maroon Ford van by *H Kimber and Sons*. One of the sons was Mr Harold Kimber. I can well remember his weekly calls to collect our grocery order - he was such a cheerful character and always had kind words for us boys. He would come up the drive with pencil behind his ear and order book in hand, approach the back door and knock, then call out 'HK!'. One day I remember that he told my mother of a new line of confectionery - it was the now well known *Kit Kat* bar which then sold at 1d for a small one and 2d for a large one. Yes, we were lucky boys that day. I'm sure that we eagerly awaited the return of the little maroon van that evening with that special order. I expect that many readers will recall that many years later Mr Kimber became Mayor of Guildford."
